Legal and practical aspects of UARA's activity on trademarks protection

- counterfeit products (fakes);
- contraband (illegal import) and distribution of original products;
- parallel ("grey") import and distribution of original products;
- illicit (unauthorized) use of IPR objects.



Main Problems Which Trademark Owners Face in Ukraine:

- underpayments and deficiency of license fees;
- consumer preference loss (due to poor quality of counterfeit products, absence or inferior quality/absence of warranty services for contraband or "grey" products etc.);
 - additional competition sales decrease profit loss.

Mentioned problems carry the next consequences for trademark owners and licensees

Possible Perpetrators:

- manufacturers of counterfeit (fake) products;
- importers of counterfeit (fake) or contraband products;
- "grey" importers;
- retailers of counterfeit, contraband or "grey" products.

Persons to Be Responsible for Mentioned Illegal Actions:

- a company acting as a legal person;
- natural person acting as an individual entrepreneur;
- company manager (director) or any other company executive, responsible for illegal actions.

Methods of Resistance and Actions to Be Taken Against Perpetrators:

I. Preventive measures and settlement:

- market surveys or constant and consecutive market monitoring in order to detect violations and perpetrators;
- investigation of routs and schemes of supply, delivery and distribution;
- warning actions against violators (sending warning or cease and desist letters, warning visits of trademark owner's authorized representatives, negotiations with violators aiming for peaceful settlement etc.);
- warning and explanatory campaign in mass media;
- pre-trial settlement.

2. Official actions:

- inspections of state law enforcement and other control authorities;
- "control purchase" procedures with further experts examinations of products;
- withdrawals, seizures or confiscations of counterfeit, contraband or "grey" products etc.

Methods of Resistance and Actions to Be Taken Against Perpetrators:

3. Prosecution of infringers:

- initiation of criminal proceedings;
- bringing to administrative or civil responsibility.

4. Initiation of civil proceedings in order to get compensation for trademark owner.

Results of the work

As our experience shows significant results of the work performed, for example, reduction of the number of online stores selling grey products by 40-70% is achieved during 3-5 months.

This indicator depends on many factors, in particular:

- possibility to identify grey products directly while monitoring website
- necessity and possibility of receiving additional information regarding identification of products
- possibility to receive confirmation from customs authorities regarding facts of importing certain (grey) products or absence of such facts



Some practical cases on the prevention of IP violations

KYB Corporation

- Cooperation since 2012
- During the period of cooperation, appropriate measures were taken in relation to 300 on line stores with subsequent elimination of violations
- On the initiative of UARA, 10 searches were conducted, as a result of which more than 1000 units of products were seized.








Sony Interactive Entertainment

- On the initiative of UARA, were performed more than 400 seizures of counterfeit goods from the customs post all over Ukraine with followed by its destruction, as a result fake goods did not got to the Ukrainian consumers.
